A LETTER FROM YOUR PRESIDENT

NVBCL working to help control Airbnb-type rentals

GAIN I BRING to your attention the issue of unregulated, online "home sharing" rental platforms (think "Airbnb") offering rooms for short-term leasing in dwellings in residentially zoned neighborhoods.

Neither the Commonwealth of Virginia nor the City of Virginia Beach has enacted laws to address these commercial enterprises, thereby presenting serious zoning, public safety, taxation, waste management, insurance, noise and parking issues. The civic league believes that this environment is unfair to residential property owners as well as conventional real estate brokers, hotels and traditional bed-and-breakfast establishments, all of which must adhere to local and state laws requiring proper land use and taxation. Most importantly, Airbnb and similar operations have no concern for the residential character of a neigh-

"Given the current and total lack of an appropriate regulatory scheme established by either the Commonwealth of Virginia or the City of Virginia Beach to address the rental of private residences through the use of any virtual reservation system such as 'Airbnb' and/or others, the North Virginia Beach Civic League opposes the use of Airbnb to rent any such residence in the City of Virginia Beach unless and until the Commonwealth of Virginia and/or the City of Virginia Beach adopts and implements proper rules and regulations for such rentals consistent with the existing zoning of residential properties within its city limits."

There is legislation pending before the General Assembly addressing online home rental platforms. While this bill is being studied, in its existing form an owner may rent his/her dwelling nightly with essentially no means for the City of Virginia Beach to identify that individual (Airbnb will not be required to disclose this information) in order to properly collect taxes and enforce zoning laws as well as building code requirements, all of which protect the character of residential neighborhoods and impose more stringent rules on commercial properties in the interest of public safety and taxation.

The City Council has recently appointed an ad hoc committee, of which I am the chairman, to study the issues and report its findings and recommendations to council before its Oct. 4 meeting. By the time you read this open letter, the committee likely will have completed its work. Nonetheless, it is important for you to understand the issues and advise council of your views.

I encourage you to visit the city's website, www.vbgov.com, and click the "Online Home Rentals" icon on the right side of the home page. The information there will provide you with a more detailed accounting of the issues at stake, the concerns of our citizenry and city officials, the work of the ad hoc committee and a platform for you to state your position on the subject.

Over the past few months the NVBCL Beautification Committee has made contact with each of the public utilities' representatives in the area to seek their assistance or cooperation in cleaning up and/or screening various utility structures in the Atlantic Avenue median.

So far, Dominion Virginia Power and Verizon have repainted their large connection boxes in the 7800 and 6700 blocks, respectively. In addition, Dominion Power has indicated it will remove the damaged poles in the 6100, 7700 and 8100 blocks, and Virginia Natural Gas will remove the abandoned riser in the 4900 block – all by sometime in October.

N.E. OVERLAY: HOW'S IT GOING?

The good news is the North End Overlay ordinance is having the desired effect.

As everyone knows, the vast majority of lots in the North End are grandfathered as duplex lots, which simply means you may build two attached houses on one lot regardless of the lot size. The North End Overlay was designed to still allow two residential structures but allow them to be detached rather than attached.

To qualify for building two detached dwellings, you must abide by the terms of the overlay, which has several design requirements and minimum spacing between the two structures. The overlay concept will allow for more architectural variations, additional light and space, and help keep developers and builders from constructing large, boxy duplexes that simply maximize square footage.

The civic league's Zoning Review Committee has had several new homes proposed under the overlay guidelines, and all designs are having the desired effect.

Thanks to everyone within the civic league who helped bring this about through both work and support.

The ZRC responses to the city are strictly opinions on what the committee feels is in the best interest of the overall North End community. The ZRC has no authority to deny or approve any variance request.

We cordially invite all North End residents to attend with their current or future applications for variances, nonconforming uses and encroachments for preliminary or final review.
