
hope we will be able to have our next general meeting in October at the A.R.E.

calls at the intersections, and we all must focus our attention on these spots to avoid a tragedy.

Additionally, there is a serious concern with crosswalks and traffic lights. When you have a white walk sign indicating that you may cross a street, there might also be a green turn arrow for a vehicle to turn at that same time – this can place you in conflict with a turning vehicle. The civic league is aware of this and is seeking a change to the traffic light patterns with the city. Please never assume that a vehicle's driver sees you. Be vigilant at the crosswalks.

Motorized scooters will soon add to the congestion in our community. On May 19 the City Council granted four companies – Bird, Lime, Spin and VeoRide – franchise agreements. The scooters were scheduled to begin rentals July 20. Below are some pertinent scooter regulations:

- 1,000 motorized scooter cap, citywide.
- Up to 40 percent of the 1,000 scooters, or 400, may be allowed in the Oceanfront Resort area at any given time.
- City Council was briefed Jan. 20 and asked that the cap be dynamic to allow an additional 20 percent at any given time for peak need.
- Motorized scooters will continue to be prohibited from the Boardwalk and parallel bike path.
- Motorized scooters may be allowed in the shared outside, bike/trolley lane but with a 10 mph speed limit.
- Parking corrals will be designated in the Atlantic Avenue/Connector parks for designated motorized scooter parking.
- Motorized scooters will be prohibited on sidewalks on Pacific Avenue to points east.
- Vendors will be required to have an education plan and staffing / management plan and many other new management requirements.
- New fees related to compensate for management of the program (including new signage to help with enforcement of the regulations).
- Vendors will provide COVID-19 related education and cleaning protocols for employees and customers.

It is likely there will be some growing pains as the rental process proceeds. The motorized scooter program will be managed by the Parking Management office of the city's Planning Department. Your civic league has already been in contact with the city and will stay engaged as the process unfolds.

Thank you again for reading this newsletter. Your involvement in your community pays dividends to all of us. Our strength is our membership. If you have not paid your dues for 2020, please consider paying them at this time. You may send a check or use PayPal on our website, nvbcl.org.

HERE HAVE BEEN some personnel changes at the city's Landscape Division. While our 89th Street neighbor Kenny Denson is still supervising our area, he is now assisted by John Brady, who has established a regular presence at the North End refilling doggie bag holders at the beach entry ways and emptying bus-shelter trash cans (an HRT responsibility).

Although the Landscape Division has taken its share of personnel cuts, they have assured us that the Resort Area and North End are still the high priorities.

Our efforts to seek a cleanup of the northwest corner of Bay Colony Drive (47th Street) and Atlantic Avenue have commenced and when completed should improve the appearance, and maybe safety, of that intersection. (Top photo)

You may also have noticed that some trees that have not survived in the median have been removed, and their locations are marked with white crosses and small flags (photo at right) to facilitate the planting of replacements in this upcoming fall/winter planting season. Most of these young trees were paid for by an NVBCL donation and will be replaced at the city's (taxpayers') cost.

As we have concluded our three-phase, 10-year Atlantic Avenue Median Beautification project, the civic league would like to entertain suggestions for future beautification projects to partner with the city. Please send any ideas to my email address (jhspruance@ cox.net) for board consideration.

# **PUMPED UP?** 48th St. pump station replacement is still alive, but don't hold your breath on the deadline

Like everything these days, the plan to replace the sewage pumping station between 48th and 49th streets is delayed.

According to project manager Chris Johnson, the design is almost complete, but the earliest start date would be this winter. It is on the capital improvement schedule for fiscal 2023, so the latest start date would be summer 2023. A bit away.

When construction finally begins, Johnson said in an email, plans call for a year to complete the project, though weather could delay it. During construction the bike/walking path will be relocated around the construction site until work is complete, he added.

The contractor is obligated to provide written notification to all owners/residents of adjacent property 30 days before work

By now, everyone should be aware of two serious accidents at the intersection of Bay Colony Drive/47th Street and Atlantic Avenue, the most recent on June 17, when a pedestrian was reported injured.

I spoke to the city's traffic engineer involved in that investigation who said that while fender-

bender reports are available soon, those involving personal injury take longer – so he did not have it in time for me to include any more information in this article. The intersection has traffic signals and walk lights as well as pedestrian-crossing signs.

Warm weather and adequate rainfall ensure vigorous vegetation growth. Although I generally survey many streets to ensure the "cone of visibility" isn't impaired, there's no way to be totally current. Thankfully, a number of you email me problem

areas, and I'm glad to send that info to the city for action. However, understand that it is the property owner's responsibility to ensure landscaping is not a hazard to traffic.

Finally, I repeat: The city does not clean our streets, and though someone will sometimes come out and unclog a blocked drain, it makes sense for us to watch them ourselves. If you see debris covering a drain, shovel it into a trash can Monday evening.

# ADD BIKE TRAILS **TO 1ST LANDING?** STUDY SAYS NO.

Efforts to add approved mountain bike trails in First Landing State Park look like they won't happen right away, if at all.

"It's going to take more conversation and more work," state Sen. Bill DeSteph, a proponent of the trails, was quoted in a July 6 story in The Virginian-Pilot by Stacy

"Such bikes are apparently harmful to the park's unique landscape, according to a recent study," Parker wrote in the story.

DeSteph - a Republican representing the entire city in the 8th Senate District – said he hopes revising the trail route "can resolve some of the environmental concerns raised in the recent study, The Pilot reported. "DeSteph and several other local cyclists started pushing a few years ago for the installation of trails at First Landing State Park. They believed the park's natural rugged landscape - a maritime forest flanked with steep, sloping sand dunes alongside cypress swamps - made it well suited for some two-wheeled fun."

The Pilot continued: "Two years ago, DeSteph secured \$50,000 from the General Assembly for the environmental impact study that recently concluded the trails were a bad idea.

"We get it that it's something people like to do, but it's got to be the right place," said Tom Smith, deputy director of the Virginia Department of Conservation and Recreation. "Sandy soils are difficult to manage in terms of bike trails. ...

Parker's story said the study reported that "cyclists already have harmed the landscape by carving out unofficial 'ghost' trails" and building "bridges over swamp sections" and cutting down trees to clear those illegal trails.

"In the steepest parts of the proposed trail segments, soil had eroded, according to the study," Parker reported. "'Once roots are exposed and subjected to repeated stresses from bike tires or foot traffic, it becomes only a matter of time before tree mortality results, stabilization of the dune is compromised, and forest integrity is degraded,"" the study said. According to Parker's story, the

study "acknowledges that the lack of facilities for mountain biking in Virginia Beach has contributed to the illegal biking activity in First Landing, but concludes sanctioned trails would further compromise the park's fragile landscape."
