HOPE THIS NEWSLETTER finds you and yours well and that you are successfully negotiating the vagaries of the pandemic. While it may seem that everything in life has changed, rest assured that the North Virginia Beach Civic League has not changed. We continue to act on your behalf daily to protect the character and community of the North End.

I miss seeing everyone at our general membership meetings and hope that we will be able to conduct a meeting in the near future. Bringing everyone together is logistically daunting, however, and we have been in discussions about numerous ways to conduct a meeting.

Of course, your safety is our first priority. One promising idea is a spring outdoor meeting on the lawn of the old Cavalier Hotel. However we may make it happen, we would love to see our members again.

I am sure you know that we have entered hurricane season. This season is like none other, though, as we are still in the midst of the pandemic. I strongly urge you to visit the Virginia Department of Emergency Management to view its "Hurricane Evacuation Guide During the

Pandemic." It's too late to view the guide when a storm in immi-

nent. A few minutes of your time might make the difference between safety and tragedy. You can find the guide online at www.vaemergency.gov/hurricanes. I also encourage you to do a web search for Virginia Know Your Zone to check your hurricane evacuation zone.

Traffic on Atlantic Avenue is an issue that concerns every one of us. I made a formal request to the City for a traffic study on behalf of the Civic League, and data was collected and analysis has begun. The study has two parts, vehicular speed and pedestrian crossings. The City collected vehicle and pedestrian data at 11 intersections on Atlantic on a typical weekday and a Saturday. The data will be used to determine priorities for pedestrian-crossing enhancements. Any improvements will be required to comply with the Americans With Disabilities Act, which will require construction and funding priorities. I also have requested that vehicle speeds be analyzed to determine if a lower speed limit along Atlantic is warranted.

I respect the process that the City's Traffic Engineering Division undertakes and hope you understand there is no immediate solution. I remain in regular communication with the engineers and will report further as progress is made.

Parking is another issue that many of you have raised. We are actively monitoring neighborhood parking and

NVBCL wants to help residents spruce up their beach walkways

The NVBCL Board of Directors has confirmed the funding for a long-existing but seldomused individual street beautification initiative.

Specifically, residents of any numbered street may request up to \$500 in matching funds from the Civic League for a city-approved, beach entryway landscaping beautification project.

It was first offered in

2007, and 87th Street residents were the recipient of our initial matching-funds offer.

Residents would be responsible for raising the initial funding for plant materials, submitting a basic plan (it can be a sketch of the plot with requested plant varietals) to the city's Landscape Management Division for approval, and a general agreement

the impacts upon our community. Construction will soon start on the Embassy Suites hotel, the last part of the Cavalier hotels campus. This construction will bring another influx of workers to the area, and their parking will impact our streets. We will remain engaged with the City and The Cavalier Shores Historic Community, which has permitted parking on their streets.

We expected to see motorized scooters again on the streets when phase III of the Forward Virginia plan went into effect. The introduction of scooters has been delayed due to the vendors' refusal to sign the franchise agreements presented to them by the City. City staff have been working to modify the agreements and were scheduled to present the modifications to council on Oct. 6.

The major unresolved issue was, unsurprisingly, liability. If council accepts the modified franchise agreements, the earliest we could again see these scooters operating would be in November.

I would like to make another pitch for the SeeClickFix app because we receive many complaints about issues that could be handled using the app. If your Civic League contacts the City about your complaint, the first question asked will be, "Was this reported?" The app allows you to submit your concern to the City, including pictures, and is easily traceable. In most instances, the issue is assigned for correction almost immediately. If the issue is not corrected, we could then intervene on your behalf with a record of your concern and submittal to the City.

In closing, I would like to thank you for your support of the Civic League. We are only as strong as our membership. We have a superb cadre of dedicated volunteers who selflessly give their time and energy to keep the North End a great place to live.

The city's Beach Operations staff recently reported they needed to take out the volleyball posts at 79th Street to remove sand blocking the 79th Street outfall bypass.

Investigation as to why the storm water is bypassing the underground outfall piping and flowing over the sand instead found that one of the two outfall pumps at 79th is not operating.

The Public Works Department indicates there are delays getting a replacement pump and that they might not have both pumps operational until November, after the hurricane season ends. Consequently, we will continue to see our "mini Grand Canyon" across the beach at 79th, and residents in the area might experience more flooding than normal.

Also, Beach Operations removed volleyball posts at 79th without a point of contact. Volleyball posts can obstruct the city's ability to groom the beach, and during beach replenishment all the posts are removed.

In the past, there was a proliferation (54) of volleyball posts and no accountability as to who oversaw them. During the last sand replenishment, Beach Operations removed all posts and

initially said none could be replaced. After extensive discussions, Beach Operations agreed to allow volleyball posts under the following conditions:

- Develop volleyball court locations at no more than one per block.
- The court will be at the base of the dune system and must not impact maintenance of the beach, including beach accesses.
- The poles must be no larger than 6x6-inch wooden posts imbedded in beach sand. They must embedded such that they can be removed when needed. Concrete of other material may not be used as part of the anchoring system.

- The NVBCL will provide names, addresses and phone numbers associated with the court locations to Beach Operations, which will keep a database of the information.
- Beach Operations will meet on the beach with the court-



responsible party to agree on the volleyball court's location.

The city recently removed several dead Black Pine trees in the dune at 71st Street. The city arborist says that this is an areawide problem and that we are likely to see more Black Pines die.

With hurricane season in full swing, some people are concerned about catamarans sailboats on the beach potentially becoming flying projectiles. In past years, there were so many of the very popular Hobie Cats on the beach that the city required owners to register them. Hobies were limited to about five per block.

Hobie Cats no longer need to be registered. When not in use, they are supposed to be stored at the base of the dunes – not *in* the dunes. Hobie Cats left in the middle of the beach or up in the dunes can be removed by the city.

for resident responsibility for sustaining maintenance.

Landscape Management officials have indicated a willingness to fast track approval as such projects are usually scheduled on a seasonal basis from the first of November through the end of March. They also will provide all necessary initial labor and associated horticultural materials, which often exceeds the cost of the plant material itself.

Checks are to be made payable to Treasurer, City of Virginia Beach, submitted to the Civic League for matching funds and the division will accept responsibility for buying plant materials, often at wholesale costs.

In response to neighbors' requests, vegetation pruning on the northwest corners of the 47th and 59th streets' medians has been initiated to improve line-of-sight safety for east-bound vehicles.

Landscape Management has also informed us that fall/ winter plantings for our two North End neighborhood welcome signs will be available by early November. **ENVIRONMENT**

BE IT RESOLVED, ATLANTIC AVE. NEEDS CITY HELP

RESORT ADVISORY COMM.

It goes without saying that with COVID-19 and the recent public unrest, the resort area suffered greatly in the summer of 2020. The good news is that Virginia Beach had the highest occupancy and visitation rates of any major tourist destination in the country this summer, topping out at 63 percent.

Although a bright spot nationally, COVID and civil unrest have taken their toll. This dismal season has motivated hoteliers, restaurant owners, retailers and private property owners in the resort area to move forward with the Resort Renaissance and multiple initiatives for improvement.

Resort leaders working with the Resort Advisory Commission have drafted a resolution to ask the City Council to approve and fund multiple initiatives to improve the resort area, starting with Atlantic Avenue, our front door. The City Council approved the resolution 11-0, and leadership is well on its way to undertaking this major task.

The resolution's basic steps are:

 That the City Council immediately re-establish a Resort Management Office in the resort area with a manager and appropriate staffing.

2. That the City complete the Mobility Plan called for in the Resort Area Strategic Action Plan within the next six months so the appropriate budget allocation can be made in the 2021 fiscal budget.

3. That the City re-initiate Friendship Patrols in conjunction with local churches and increase Atlantic Avenue entertainment programming to maintain a safe and friendly atmosphere for visitors and residents alike.

4. That the City implement a customer-friendly parking plan with guidelines and hours of operation with public and private lots that put public safety as a top priority.

5. Authorize the Resort Management Office to implement immediate and continuing maintenance actions that can address the growing list of areas in need of immediate assistance.

6. That the City provide adequate resources to increase police presence on Atlantic Avenue.

7. That the City Council and Resort Advisory Commission develop a Revitalization Program for Atlantic Avenue infrastructure improvements that reflect the art, history and culture of Virginia Beach and will be funded in budget years 2021-2025.

In addition, the Strategic Growth

TRAFFIC SAFETY

DO YOU KNOW "GOLF CART" RULES OF THE ROAD?

Apparently, there have been several complaints forwarded to the Police Department alleging illegal golf cart use on public roadways within the 2nd Precinct, so we want to alert our members to the concerns of law enforcement.

Officers at the 2nd Precinct have purportedly been made aware of the complaints and the locations where they are taking place.

First and foremost, *no* street in the geographical area of the North Virginia Beach Civic League has been designated for golf cart operations; therefore, city and state laws for the use of "low speed vehicles" are applicable. These laws include, but are not necessarily limited to, the following:

A low-speed vehicle heads down Atlantic Avenue recently.

- Vehicles can reach speeds of 20 to 25 mph.
- Have a vehicle identification number (VIN).
- Must display license plates.
- Must be equipped with head lamps, front and rear turn signals, tail lamps, break lamps, reflex reflectors (red one on each side and one on the rear), exterior mirror on the driver side and an interior mirror or exterior mirror

- on passenger side, parking brake, windshield and a seatbelt for each designated seat.
- May not be operated on any roadway with a speed limit above 35 mph.

Any person operating a lowspeed vehicle must have in his or her possession a valid driver's license, which again by definition requires compliance with all state and city motor vehicle laws. A low-speed vehicle must also be registered with DMV and insured with Personal Injury Protection and Property Damage Liability coverages.

We have not attempted to provide an exhaustive statement of various city and state laws applicable to the operation of golf carts and other low-speed motor vehicles, nor is this article intended to provide legal advice to anyone. It is intended to alert our members to law enforcement concerns.

If any of you have questions about the use and operation of these vehicles, please consult an attorney and/or the state Division of Motor Vehicles.

ZRC RESUMES REVIEWING APPLICATIONS

The NVBCL Zoning Review Committee is now back meeting at its regular time and reviewing applicants' requests for variances.

We remind our neighbors that developers have three options for North End properties: a single-family house, duplex or two detached cottages on one parcel.

The detached-cottages option is an incentivebased design guideline, and a developer must comply with the design criteria in the overlay ordinance.

We also remind our neighbors that any opportunity to determine what type redevelopment happens on your street starts with the "Seller of the Parcel." Once a parcel has sold, it is in the hands of the buyer, who has the three by-right options listed above.

"STREET CLOSURE"

Save our feeder road?! Well, no need.

If you saw the orange signs indicating a request for a "road closure" involving 74th, 75th and 76th streets off the feeder road in August, you can be forgiven if you thought, "What, they want to close the feeder road?!"

They do not. Turns out it involves an unusual land ownership issue that impacted the residents' properties behind their homes and running along a 10-foot right-of-way – not an actual road – between the properties of one street and those of the other, according to Gerrie West, one of the neighborhood's organizers.

To protect their properties from possible encroachment by right-of-way owners, the residents banded together to buy each 5-foot segment.

Easier said than done, involving real estate law and city bureaucracy. In any case, they had to get the City Council's OK, which they finally did Sept. 15.
