A LETTER FROM YOUR PRESIDENT

# THANKS TO YOU, THE NORTH END KEEPS STRS OUT

Massive efforts by you, our residents, turned back the equally massive effort to expand short-term rentals, which threatened to change the nature of our residential neighborhood.

AM HAPPY to report that due to *your* efforts, we have kept new short-term rentals out of the North End. This victory clearly showed the power of the citizen's voice to influence city govern-

ment. One City Council member told me that the council didn't want to "stir up the North End hornets' nest" again.

I cannot thank you enough for the support you provided every time we requested it. You should be very proud of your efforts and the results that you achieved. The Civic League now has over 960 members.

which makes us a formidable voice for our neighborhood. This number is up significantly from prior years. Thank you for being a member of the NVBCL.

Existing legal STRs are allowed to continue to operate within the city's new guidelines for STRs. These new requirements include a 4-square-foot sign stating that the property is an

STR, and displaying the STR hotline phone number; a safety inspection every three years; and a maximum occupancy for decks. Fines are \$200 for the first offense and \$500 for each subsequent offense. The hotline telephone number to report an STR problem is 757.210-5385. I encourage everyone to call the hotline every time you see a problem with an STR.

The city has hired part-time employees to monitor STRs, which is a step in the right direction. This enforcement, coupled with our neighborhood involvement, will help maintain the tranquility of our residential neighborhood. Please rest

After the City Council vote July 13, new STRs are now allowed only in the Oceanfront Resort District, which runs from First Street to 42nd. This district is zoned for commercial

use, and STRs have been determined to be an appropriate activity based upon input from the City Attorney's Office. To establish an STR in the Resort District, one must apply for and receive a conditional-use permit from the City Council. You may build a hotel in this area, so STRs are a logical extension of that zon-

ing. Thankfully, we live in an area zoned residential, where STRs do not generally fit the fabric of our community.

While this phase of the STR fight has concluded, I will now focus on assisting the Commissioner of the Revenue (COR) with legislation at the General Assembly to allow sharing of COR data with the city's Planning Department. Commissioner Phil Kellam is not allowed to share his data on STRs with Planning, and we will seek to have that restriction lifted through state legislation. This would help the Planning Department identify those STRs that pay taxes but have not registered and complied with Planning Department requirements.

I continue to hear from many of you about traffic on Atlantic Avenue, trash collection, parking and beach access. The Civic League has not forgotten these issues and will continue to seek improvements for our neighborhood.

Your involvement on the STR issue has been spectacular. We need your continued involvement to further improve life in the North End. Please consider joining an NVBCL committee. Our Board of Directors and committees have had the same membership for many years – new input and new ideas are most welcome and will help improve our Civic League and our quality of life in the North End. ■

# "The AVE" A new vision for Atlantic?

The Resort continues to rebound. Visitation was up, and bookings have been coming in fast. We are grateful to see the tourism we experienced this season.

"The AVE" project has been constructed to test options for redesigning Atlantic Avenue. It is a "tactile urbanism" installation, from 17th Street north to 20th. This is a direct result of the hard

work of volunteers who serve on the Resort Area Mobility Plan committee, or RAMP. We are testing options for such things as lane reduction, bike lanes, wider sidewalks, and outdoor cafes.

A great example of a similar "Main Street" renaissance occurred in Hendersonville, N.C., a few years ago. A similar straight, four-lane section was transformed into a vibrant, active downtown experience using a serpentine alignment. This created areas along the street for significant

Hendersonville, N.C., replaced its straight-line "Main Street" with a serpentine alignment – an example a Virginia Beach resort area committee has looked into.

outdoor cafes, seating areas, bike parking and open-space greenery.

The Hendersonville street redesign was considered a great success – for increased business activity and visitation – and won several national design awards. We

# **City removes swings from its live oaks**

Damaged tree leads city to remove all residents' private swings from Atlantic Ave. median.

Keeping the Atlantic Avenue median, our North End linear park, uncluttered, accessible and beautiful has been a long-standing mission of your Civic League.

Because it is all city of Virginia Beach property, this is primarily accomplished with the ongoing cooperation with various city departments, primarily with the Parks & Landscape Services but also the City Arborist, Public Works Department, city Beautification Commission, various garden clubs and organizations such as Friends of Live Oaks – and residents like you!

Unfortunately, there are occasions when sometimes well-meaning residents usurp the median areas with personal recreational attachments, such as numerous tree swings having been hung on live oaks. These swings, as well as benches and basketball standards, are in violation of the Virginia

Beach Municipal Code (Sec. 23-29) as it applies to trees, shrubs or other vegetation on city property. These violations have been removed by the city and could be

reclaimed by contacting the Parks & Landscape Division.

To quote our city arborist in part: "... Damage ... often leads to tree health issues and their eventual removal. When too much

weight is placed on tree limbs, it eventually leads to broken branches and open wounds that have a negative effect on tree health. We want to prevent that type of damage ... "

All the swings were removed as of Sept. 21, according to Parks & Landscape Services. They were taken to the P&L facility

## Before you sell, talk to us

Construction at the North End is very active. Property owners are selling to developers, who are tearing down older cottages and building duplexes or the detached-cottage schemes.

We recommend that before selling your property to a developer, talk with the NVBCL Zoning Review Committee regarding your options for redevelopment.

The ZRC has had several requests recently about what is required to have a house remain in place and be vested. For years, the city used the "50% rule" in terms of

the amount of house that had to remain to expand in the location on a property if the house was nonconforming. Please reach out to the ZRC if this is an issue you are reviewing.

We remind our neighbors that developers have three options for North End properties. They are a single-family house, a duplex or two detached cottages on one parcel.

The detached-cottages option is an incentive-based design guideline, and a developer must comply with the design criteria in

the zoning overlay ordinance.

We also remind our neighbors that any opportunity to determine what type redevelopment happens on your street starts with the "Seller of the Parcel." Once the parcel has sold, it is in the hands of the buyer, who has the three by-right options listed above.

The ZRC is meeting at its regular time and reviewing applicants' requests for variances at 6 p.m. the second Thursday of the month at the A.R.E. Visitor Center, 67th Street at Atlantic Avenue.

hope to transform our Atlantic Avenue soon.

Several transportation projects are in the works including the planning for Laskin Road from the roundabout to Birdneck Road, Pacific Avenue safety improvements and streetscape improvements on 17th Street from Pacific Avenue to Cypress.

The Atlantic Park surf project continues through the design process but has been delayed due to COVID-19 and rising construction costs. The City Council might vote on whether to extend the development agreement.

Several other projects are underway including the Embassy Suites hotel

the Embassy Suites hotel just south of the Cavalier Beach Club, the Hyatt Place at 36th and Atlantic, and a 17th Street craft brewery planned for property between Parks Avenue and Washington Street.
