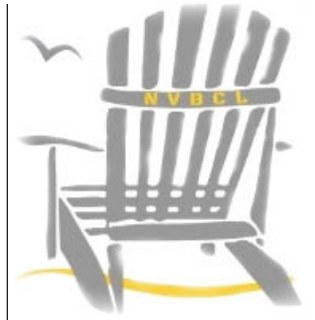

## A LETTER FROM YOUR PRESIDENT

# NVBCL faces our issues with one voice – yours

From short-term rentals challenges to zoning protections to intrusions into our beautiful dunes to special parking issues – our civic league members step up to add their strength to help us preserve and protect what makes the North End special.

**H**APPY SPRING! I for one am hoping a mild winter gives way to an early start to summer weather. I want to start off with a thank you to you all: Over the past several years, we have called on you, the members of our civic league, an increasing number of times to lend your voice to our causes. Your response is always resounding and helps shape the outcomes of the issues challenging our area.

We do this because of the importance of the recent issues we face and the fact our greatest asset as a civic league is the strength of our collective voices.

**Because of you**, we were once again successful in opposing legislation at the state level that would have allowed for the return of short-term rentals with no regard for our local legislation.

I also want to give a special thanks to

the co-chair of our Government Affairs Committee, Andy Cohen. Andy was essential in orchestrating our opposition to multiple bills introduced during this past General Assembly. (See his story below, on this page.) He spent countless hours speaking to lawmakers and traveling to be our representative in Richmond every time the opportunity presented itself.

We fully expect the issue to return next year, and we will continue to keep you informed when we learn of new efforts or bills pertaining to this issue.

**I also want to highlight** the work that has continued on several other important issues directly impacting our community.

Recently our Zoning Review Committee was able to oppose a challenge to our zoning regulations that threatened to create a pathway for developers to create substandard, single-family lots below the current minimum required lot size. Our estimates indicated such a zoning change would have had the potential for the creation of up to 40 new substandard lots throughout the North End and could have resulted in a dramatic effect

on housing density.

A favorable vote by City Council, led by Councilman Worth Remick, helped

# Thank you! NVBCL folks' efforts help keep STR bills from advancing in General Assembly

Thanks to efforts by so many of you, we are pleased to report that the short-term rental bills that we opposed did not advance in the most recent session of the Virginia General Assembly.

These bills would have exempted licensed Virginia real estate agents from ordinances that Virginia Beach and other Virginia localities have adopted to regulate STRs.

The sponsors of the House and Senate bills, recognizing that their bills faced unexpectedly strong opposition, asked the respective House

and Senate committees to refer their bills to the Housing Commission (<http://vhc.virginia.gov>) for further study. In doing so, they stated that they expect the Housing Commission study to resolve opponents' concerns so that similar, if not identical, bills can be introduced and passed next year.

So state legislative action on STRs has been delayed for a year, but STR advocates are clearly not giving up.

After those committee meetings, one of our civic league members in attendance was able to speak with the vice chair and a member of the Housing Commission about including an NVBCL representative

to strengthen our current zoning regulations.

We also have made progress in the effort to protect our dune systems and stop encroachments beyond property lines along the Oceanfront.

After a receptive meeting with Mayor Bobby Dyer, we were invited to present our concerns in front of City Council. We are hopeful we will be able to work with multiple city departments, council members and the mayor to come up with a sensible solution to limit and roll back dune encroachments to preserve this valuable natural resource.

As of writing this newsletter, we continued our opposition to the special parking exemptions granted to the Cavalier Shores neighborhood.

What was a temporary program to accommodate construction traffic from the Cavalier Resort project was extended April 4 by an 10-1 vote of the City Council until 2026.

We see no reason for special treatment beyond its intended purpose to have been granted.

Finally, I want to remind you that our City Councilman, Worth Remick, will be the speaker at our next general membership meeting Monday, April 17. We have changed from our normal meeting date to accommodate his obligations with council meetings.

During his brief council tenure, Mr. Remick has already proven to be a great advocate for our community. We look forward to hosting him and continuing our work with him on any issues that arise affecting our NVBCL community. ■

## Dune stories Clearing walkways, adding protection

You may have observed the city's Beach Operations Division using heavy equipment to create a buffer area between the dunes and beach-access walkways, pushing sand back to either side of the walkways.

The city does this annually to reduce the amount of sand moving from the dunes and covering walkways. The above photo of 77th Street is a prime example of the walkway buffer zone as sand is pushed back. As this clearing out was being accomplished, the city also cleared off any existing sand from the walkways.

The request I most often get from our members is to ask the city to clear the walkways of sand. There is some good news on that front. The city is in the process of purchasing a sweeping attachment that will more effectively and efficiently respond to clearing requests. The bad news: It will be several months before it's delivered and mounted – but the city has definitely heard our requests and is addressing the problem.

In the interim, I have spoken to several of the NVBCL's area directors (you can find their names and contact information on the back of this newsletter), and we are going to form a "shovel

and broom" group to help keep the walkways clear. Many residents, including Phil Curtin on 77th Street, are already sweeping sand off walkways. If you would like to volunteer to keep the walkway on your street clear, please contact the area director for your street.

In the coming weeks you will begin noticing new "Keep Off the Dunes" signs going up.

Most dune damage results from individuals walking through the dunes, stepping on the sea oats and grasses, and crushing or breaking plants. Please use the walkways. Do your part to help protect and maintain the dunes.

Peter Langlands was in Cocoa Beach, Fla., recently, participating in a sea oats replenishment project sponsored by that city and supported by local residents. Pete, an NVBCL member, was part of a group that planted approximately 3,000 plants in a little over an hour. Our North End dunes have

several spots that will need new plants in the coming year.

Based on Pete's experience, I have contacted the City of Virginia Beach and asked if it could provide the plants and required equipment – the NVBCL would do the planting.

Hopefully, we will have a decision from the city in the coming weeks.

Pete has offered to chair the project as it moves forward.

The city is experiencing an increasing number of Oceanfront residents, from Sandbridge to the Lesner Bridge area, attempting to extend their yards into the dunes.

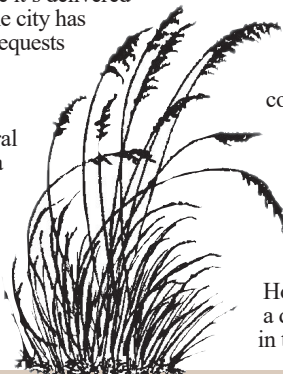
Any time a resident encroaches by removing natural plants, extending flower beds or cutting down trees, the dunes are damaged – and dunes are our primary protection against hurricanes and storms. Damage to the front or back of the dune line has been described by several environmental engineers as "death by a thousand cuts."

The city is proposing to re-establish the Beaches and Waterways Commission to find solutions to encroachment appropriate for each beach area. The dune issues in Sandbridge are different from the North End – no single answer will address all the concerns.

We have been meeting with City Council members and staff in an effort to discuss what we are seeing in an ongoing effort to protect and preserve the North End dunes.

Our position has been and continues to be not to support encroachments into the dunes. Please do not extend your flower beds or thin out or cut down growth in the dunes.

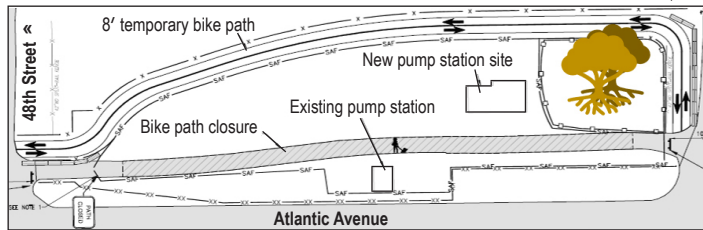
# Bike path will have to move over when city replaces sanitary pump station at 48th Street this summer

After almost seven years, the city says it's ready to replace the 48th Street Sanitary Pump Station – and that will mean temporarily rerouting part of the bike path.

Construction is scheduled to begin sometime this summer and is expected to take about 18 months, city engineer Randall W. Allen told North Virginia Beach Civic League members at their Jan. 17 meeting. The project was last presented to the civic league in July 2016 but had been delayed for various reasons, including those related to the COVID-19 pandemic, Allen said.

Replacing the pump station "is required due to age and inadequate capacity to service the existing community," according to the Power Point presentation Allen used during the meeting. The new station, ex-



pected to last about 50 years, should "avoid sanitary sewer overflow and ensure service reliability."

The new pump station will be somewhat bigger and built farther

away from Atlantic Avenue, 50 feet from the existing structure, Allen said, and the work will mean

a "temporary bike/pedestrian path will be available during the construction," according to the presentation, and it will be paved, Project Manager Dawn Ray Panaguiton said. Also, trees in the site's northwest corner will be preserved, Allen added.

Allen's presentation also included this construction information:

- Public Utilities will provide a notice before construction begins.
- The site will be restored to its original condition, including the paved bike/walkway path.
- A construction inspector with be the on-site point of contact.

on the commission work group that will study the STR issue and make recommendations about how to proceed. They said the commission will probably vote to set up the work group when it next meets sometime in April. Appointments to Housing Commission work groups are controlled by the chair, Delegate Daniel Marshall (District 14, Danville), so if any of you have influence with him, please contact Andy Cohen ([acohen@gmail.com](mailto:acohen@gmail.com)).

Thank you again for the efforts by so many of you to contact our state senators and delegates to express our opposition to these STR bills. There are also still multiple pending lawsuits that challenge Virginia Beach's authority to regulate STRs, so we are monitoring those as well.

We will let you know how and when we need your voices again. ■

## ZONING ISSUES

# City, ZRC still setting priorities for development

The NVBCL Zoning Review Committee continues to work on several initiatives with city planning staff to revise regulations as they pertain to redevelopment. ZRC members met in person with this committee last June 9 regarding the redevelopment topics listed below. Those in **bold** are advancing with the Planning Department:

1. Remaining nonconforming parcel re-subdivisions into new nonconforming parcels is under study
2. **Clarifications to the R5RNE zoning ordinance regarding the "Two Detached Cottage" options, graphic examples and narrative revisions in the zoning ordinance**
3. **"Two Detached Cottage" option allowed on 7,500 square foot parcels or larger**
4. **Revisions to the R5RNE zoning ordinance, allowing garage apartments "by-right"**
5. **Establishment of the R5RNE Zoning/Civil Inspector**
6. Public Works Real Estate participation and processes regarding public right-of-way (ROW) encroachments, including Oceanfront properties and associated dune systems and privatization of ROW

property frontage with site construction that reduces public parking; this is under study with Beaches and Waterways Committee.

**7. The city's zoning ordinance definition of impervious cover with respect to permeable pavement systems**

**8. Interior Oceanfront parcels with no direct attachment to a public ROW – impervious cover hardship**

9. Property-line vacation requirements for redevelopment

Recently, the NVBCL Zoning Review Committee opposed the subdivision of nonconforming lots into new nonconforming lots for the purposes of construction of two single-family houses on nonconforming lots.

Our concern was, if allowed, this subdivision would be applicable to the remaining 22 nonconforming 30-foot parcels at the North End. The City Council listened to the NVBCL concerns and denied the subdivision request.

The ZRC will continue to participate in the Planning Department discussions and will report the outcome of the final resolutions to the NVBCL general membership as soon as possible.

**The ZRC continues** to review requests for variances at 6 p.m. on the second Thursday of the

month at the A.R.E. Visitor Center, 67th Street at Atlantic Avenue.

Construction at the North End continues to be very active. Property owners are selling to developers who are tearing down older cottages and building duplexes or the detached-cottage schemes. We ask that before you sell your property to a developer, talk with the ZRC regarding your options for redevelopment.

**We are seeing** an increase in illegal, non-permitted construction including driveway expansions, shed construction, decks, terraces, fences and house additions. If you see construction on your street and do not see a visible City of Virginia Beach permit displayed on the property, please contact any member of the ZRC or call the city's Permits and Inspections office at (757) 385-8060.

**We remind our neighbors** that any opportunity to determine what type of redevelopment happens on your street starts with the "Seller of the Parcel." Once the parcel has sold, it is in the hands of the buyer, who has the three by-right options listed above.
