Our October guest speaker was Delegate Anne Ferrell Tata, who provided a very informative presentation regarding her actions to support North End residents.

She is in the middle of her second term representing the 99th District, which consists of an estimated 85,000 residents. She has a passion for a number of areas, and she spoke on three of them – supporting our military, foster care and support for individuals with disabilities. She has sponsored legislation focusing on Foster Care for Kids, Human Trafficking, Health Care Training and Antisemitism.

Del. Tata is also protective of localities and works very closely of localities and works very closely with Virginia Beach officials to ensure our priorities are heard in the General Assembly. She supported city efforts to obtain \$7 million in state funding for the new water treatment facility and an \$11 million grant for city infrastructure. In times of tight budgets, these were true wins for our residents! She also has been working directly with two of our NVBCL Board members – Parker Hannas and Andy Cohen - regarding short-term rentals legislation. This is a true testament to her position of ensuring our voices being heard in Richmond.

Del Tata is also focused on the future: she sits on the Science and Technology

Committee and the Subcommittee for Artificial Intelligence. AI has the potential to provide significant new business and financial opportunity to the economy and our region. She is also engaged in tracking the Offshore Wind Turbine pending bill(s) and the

benefits it can bring to the city. She also made one point abundantly clear: She wants to hear from us as a civic league and individuals. If you have an issue or concern, she asks that you contact her office to discuss it.

Del. Anne Ferrell Tata has proven to be a seasoned voice woring in a bipartisan manner to address the many issues facing Virginia Beach. She works large, complex issues and individual concerns, but they are all equally important. In my opinion, we are fortunate to have her as our delegate.

## Sand management is also our job

We often get asked about cleaning the sand off our individual beach walkways, and this is our responsibility as good neighbors to keep them clear from trash and sand from daily usage.

If the amount of sand can be swept or blown off with a leaf blower, that's our job to do. It's a privilege to live where we do, and we should be good stewards for our neighbors and others who want to enjoy this amazing beach. However, when a storm significantly blows a lot of sand onto the walkways, Beach Operations has the necessary equipment (bobcat) and once notified will come and clear large amounts of sand from the bench area down to the level sand line of the beach.

It's winter, so we go to the beach less often - but that doesn't mean there's no activity down there.

Beach Ops is happy to report the city will install completely new gates at three restricted-access points to our beach: 57th, 68th and 79th streets. They will be galvanized steel posts with aluminum gates. The timeline wasn't pinned down as of press time, but Beach Ops reports this should happen sometime over the winter.

I had reported in the April

newsletter that the Army Corps of Engineers would perform beach replenishment from 16th to 42nd streets during the summer. Well, obviously that didn't happen, but there seems to be a firmer start date now. The project should begin around the end of January if all other projects the Corps is working on go as planned. This is a necessary project for the resort area, especially in the lower 20s streets - that area has suffered some notable erosion in recent weeks.

## **VA Beach manages budget** by anticipating rising costs

When the Virginia Beach City Council adopted the city's fiscal 2024-25 budget May 14, the annual budget of more than \$2.6 billion was just under a 3 percent increase from the prior fiscal year -- not exactly a spending blowout.

Like everyone, municipalities have struggled to contend with the inflation of the past few years. No matter where blame for inflation can be assigned, it is certainly true that cities, counties and towns have struggled to meet municipal employees' higher wage and benefit expectations, and increasing costs of everyday items like gasoline, facilities management and maintenance of our unique hometown assets. The care of our beaches, parks and schools became more expensive, just like the cost of eggs and bread.

Many of us were disappointed in the reduction of our real estate tax rate from 99 to 97 cents per \$100 of assessed value. However, it is important to remember that we still have the lowest tax rate of any South Side city. For example, the rate in Norfolk is \$1.23 per \$100 of assessed value – do that

math on your assessment.

It's also likely the case that our property values increased last year more dramatically than most other neighborhoods. There are roughly 186,000 homes in Virginia Beach, and our neighborhoods are not all alike. Coastline is finite and valuable, so we and our North End neighbors feel the pinch more acutely.

As we ease into 2025, we will see many changes at all levels of government. We already have new City Council members and statewide elections next year. Our NVBCL leadership will closely monitor budget and tax issues to ensure that our neighborhood is well represented, heard and listened to on economic matters that are important to us.

## **NVBCL** continues keeping tabs on STR and ADU bills

Our Legislative Affairs Committee is watching for legislative bills on Short-Term Rentals (STRs) and Accessory Dwelling Units (ADUs) in the 2025 Virginia General Assembly session, which runs through Feb. 22.

As in prior years, we will be prepared to act quickly as bills are filed and scheduled for committee hearings. When that happens, we will let you know how you can help. We appreciate your help in contacting our

STRs: As of Dec. 10 only one STR bill had been pre-filed. House Bill 1557 (See link at NVBCL.org for STRs and ADUs) is identical to HB695 that died in committee in the 2024 session. This bill would require STR platforms, including Airbnb and VRBO, to provide data to substantiate the occupancy taxes they pay to localities, and it would give localities the authority to require those platforms to remove listings of noncompliant STRs. NVBCL supported HB695 in the 2024 session, and we expect to support HB1557 in the 2025 session.

**ADUs:** In the 2024 session, Senate Bill 304 (same link at NVBCL.org for STRs and ADUs) would have allowed an attached or detached ADU on any single-family residential lot. We expect a similar bill to be introduced in the 2025 session. NVBCL supports allowing more ADUs in the North End within appropriate limitations, including that ADUs may not be used as STRs, but we opposed SB304 because it went too far in pre-empting local authority to determine those limitations. We met with the bill's patron, who was receptive to our input on how to improve it if they file it for the 2025 session.

STR Enforcement Task Force: Task force chair Andy Cohen is working with city staff to finalize the task force report and recommendations in preparation for presenting them to City Council, tentatively scheduled for

### Overall crime down in the city

Seven categories of crime in Virginia Beach declined by double digits last year, according to statistics presented Nov. 13 to the Police 2nd Precinct Citizens Advisory Committee.

The following are year-over-year data as of Sept. 30 for reported crimes in the entire city, according to 2nd Precinct Commander Capt. Bradley Wesseler:

Criminal homicides down 54.9 percent

Shooting incidents down 47 percent

- Overall violent crime down 15.3 percent
- Rapes down 22.9 percent
- Aggravated assaults down 18.9 percent Thefts of motor vehicles down 27.9 percent
- Larcenies from motor vehicles down 40 percent

Capt. Wesseler also reported that Virginia Beach hosted 14.1 million overnight guests last year who spent an estimated \$2.5 billion, according to the city manager's office. CAC President Connie Agresti said this revenue translates into a tax offset of almost \$1,800 per household.

During the Christmas and New Year's holidays, Wesseler said the police planned to increase patrols of mall parking lots, but he described actions we can take to protect ourselves all throughout the year: Always be aware walking to your car, and if you feel unsafe return to the store; park in well-lighted areas and lock your vehicle as soon as you exit or enter it; do not unlock your vehicle from a distance because the beep or flashing lights can alert potential thieves; beware of anyone loitering, looking into vehicles or testing vehicle handles, and notify police or mall security of suspicious activity; keep your purse latched or zippered closed and on your person -- cross-body straps are more secure than over-the-shoulder straps.

Regrettably, mass shootings do occur, and malls are so-called "soft" targets. If you hear gunshots and cannot readily exit the mall, go to the deepest part of a store and shelter in place. Silence the ringer on your phone, and text 911.

A longtime resident of 78th Street in the North End, McBride embodies the neighborhood's spirit of community service through her role as a Life Member of the Virginia Beach Volunteer Rescue Squad, an organization that has proudly served the North End and greater Virginia Beach for more than 70 years.

The Volunteer Rescue Squad operates entirely through the generous support of public donations. McBride's commitment to these emergency medical services has manifested through various leadership roles within the organization. Most notably, she served as Chief of the Virginia Beach Volunteer Rescue Squad during 2014 and 2015, overseeing operations in the busy Oceanfront area. The Oceanfront squad faces unique challenges, responding to emergencies in one of the city's most populous and tourist-heavy districts, particularly during the peak summer season. Her leadership capabilities and dedication to the community didn't stop there. Over the past two years, McBride took on a crucial role as Volunteer Deputy Chief with the Department of

EMS. In this position, she has helped coordinate and oversee operations across all 10 volunteer rescue squads that comprise the VB Rescue Volunteer EMS system, ensuring that each squad maintains the highest standards of

emergency medical care and service delivery.

The Life Member status bestowed upon McBride by the Virginia Beach Volunteer Rescue Squad speaks volumes about her long-term commitment to the organization. Her journey through the ranks of our emergency medical services system showcases the vital role that volunteers play in keeping the community safe. Her progression from squad member to chief, and now to a systemwide leadership

### **Zoning Review Committee**

The NVBCL Zoning Review Committee continues to review applicants' requests for variances at 6 p.m. on the second Thursday of the month. Recently the meetings have been held virtually via Zoom. If you wish to meet with the ZRC, please let us know – contact information is at the end of this report.

Construction at the North End continues to be very active. Property owners are selling to developers who are tearing down older cottages and building duplexes or the detached-cottage schemes. We ask that before you sell your property to a developer, to talk with the ZRC regarding your options for redevelopment.

We remind our neighbors that developers have three options for North End properties: single-family house, duplex or two detached cottages on one parcel. The detached-cottage option is an incentive-based design guideline, and a developer must comply with the design criteria in the zoning overlay ordinance.

We also remind our neighbors that any opportunity to determine what type of redevelopment happens on your street starts with the "Seller of the Parcel." Once a parcel has been sold, it is in the hands of the buyer, who has the three "by-right" options listed above.

We are seeing an increase in illegal, nonpermitted construction including driveway expansions, shed construction, decks, terraces, fences and house additions. If you see construction on your street and do not see a city building permit visibly displayed on the property, please contact any member of the ZRC or call the city's Permits and Inspections office at (757) 385-8060.

## Getting to know my new role with the NVBCL

Over a series of three days recently, I met with representatives from the city's Public Works Department divisions for stormwater, traffic and waste management. As the new chair of the Streets/Utilities/Public Safety Committee, I wanted to meet the folks I'll be interacting with in my new role and wanted to get a better understanding of the issues important to our civic league.

Each group complemented our willingness to reach out, and they also said the NVBCL was a good partner for them. They'd be happy to speak at one of our regular meetings.

For the stormwater folks, the issues are beach replenishment/nourishment (although not as much at the North End) and maintaining the stormwater pumping stations along Atlantic Avenue. There is bond money available for this, and their comprehensive

plans are available on the city's website: virginiabeach.gov – search Stormwater, then then click on Stormwater – Planning.

For the traffic folks, the main issues were the proposed pedestrian crosswalk improvements along Atlantic Avenue and the issue of encroachments into the public right-of-way along the numbered streets and their effect on parking. Homeowners often plant bushes in the ROW or they extend landscaping and driveways wider than 12 feet – some with pavers and gravel.

They will be working with us more to enforce and address these encroachments and to prevent abuses. Each year before Memorial Day, traffic staffers drive around looking for offenders.

Waste management folks' main issues are the tight turning radii for their collection trucks as well as live oak branches interfering with the trucks' lift mechanisms. A few weeks ago one such branch caused extensive damage to a truck.

These meetings were very productive and allowed me to get to know the city folks I'll be dealing with.

# **Dunes protection** survey results

In the last newsletter I asked a series of questions regarding "should we do more to protect the dunes?"

Of about 85 emails, calls and conversations received, only three Oceanfront residents suggested that encroachments were acceptable in the dunes. All the other responses were that we should do everything possible to protect and maintain the dunes.

The following summarizes the responses – "The dunes on Virginia Beach are our first line of defense against storms, tidal surges and rising sea levels. The beach and the dunes belong to the city and, therefore, to everyone – not to any individual ..." Other responses: "Listen to the VRMC, VIMS, Lynnhaven River Now and other environmental engineers who emphatically state, "Stay off and stay out of the dunes."

The NVBCL Board of Directors unanimously voted several years ago in favor of fully protecting the dunes. We will continue to listen to our members and work with the city to find the best possible solutions to do just that.
